3. Public Comment - Gloria Guzman

Gloria Guzman with The Alamo Area Council of Governments (AACOG) works as a housing navigator mainly with the elderly (those 60 and up) and those experiencing a disability for counties in the AACOG area. Gloria stated that while she and other agencies were at the conference in Austin for Housing Equals Healthcare, Cecil King with CHCS came up with an idea about securing household necessities for clients. The idea is to create a warehouse full of new, not used, goods and furniture for those moving into housing. They spoke with someone at Bed Bath and Beyond and they had an idea to get items from them that were dented or returned as it would be easier for them to write them off as a charity rather than trying to sell these damaged or returned goods. Instead, they can call those in charge of the warehouse and they can go and pick up the items to build up the warehouses stock. Another idea for the warehouse is to have a small storefront where they can display some items for sale to make small revenue to support the program. Guzman also spoke with a few churches who stated they could help support the endeavor financially. Guzman spoke with a bank who stated they could also help financially by putting the marketing materials on their website as well as help with fundraisers if they need specific items. Guzman believes that this is something that is viable that can be presented to the city, to the county, and to the Texas Director of HHS who offered to help write grants for this endeavor. St. Mary's school of law also stated they would offer their services to help with any legal matter that was necessary



to complete this task. Guzman stated that she can be contacted with any questions or if any agency would like to offer support. Her email is gguzman@aacog.com.

- b. Measure 1: Length of time persons remain homeless This measure calculates how effective our system is, how quickly are we placing people into PH, and how we prioritize those persons. The objective is to reduce length of time homeless.



- c. Measure 2: This measures the extent to which persons who exit homelessness to permanent housing destination and return to homelessness have overlapping exit dates, exit destinations that are not completed, are significant with emergency shelter and street outreach, and have "other" being used as a category.
- d. Measure 3: This measure expresses the number of homeless persons.
- e. Measure 4: This measure expresses income-specifically for CoC funded projects.
- f. Measure 5: This measure expresses the change in the number of persons entering ES, SH and TH projects with no prior enrollments in HMIS.
